The concept of ministerial business, is different from business in the secular realm. His 501(c)3 designation has been ended.

He set up with the State and the Federal as a 501(c)3 non-profit. But he realized that you don't have to have that designation if you operate in a specified way.

3 trimesters will explain how to conduct the specified way.

Ministerial Business: that concept is foundational. This is the focus of the first trimester. You have to have a paper trail demonstrating the structure that qualifies you with professional requirements, business requirements, credential requirements, and your government requirements. A review of these will happen for your cooperation sole.

Terms: Ministerial Business. This starts with service to humanity. The business is what God calls you to do, and the way it should be done. This is decided by your calling from God. What ministry God calls you to, He wants you to duplicate and replicate. The key realization is that it is for ministry.

Education Crisis Intervention is build upon the foundation of Educational Life Empowerment.

Service Leadership: How do I serve the One and the ones I am serving? Asking, "How do I best serve you?" Serve means putting others before yourself, which requires you to humble yourself. You cannot serve them in what they want, but rather serving them in what they need.

Your portfolio is important to validate your service leadership.

The Government has no jurisdiction over the ministry that God has entrusted you with as an overseer.

508 vs 501 (c)3. People can donate tithe, you can have membership; receive grants; there are 22 income streams that can flow into either. 77 nations recognize this corporate sole structure.

Operate by your religious tenants, In service to humanity, duplicate and replicate, document all that you do so that you cannot be accused, though you do not have to expose your records. Just the fact that you have records is a good defense. You are not immune to scrutiny, but you will be less easy to accuse.

Validate what you are called to do, being credentialed to do, by others beyond you. You do your business plan as part of a book or as a thesis. If you are doing what you believe, with documentation and showing your fruit, then you will avoid the scrutiny of fraud. Thus there are business requirements, ministerial requirements, professional requirements, and credential requirements.

You are not working for yourself or for others, but only for God. Study, learn to be quiet, do your own business and work with your own hands, not depending on others. vs 12 says you will have the ability to help others. To Know God and serve God. Acquire the skills to serve God i.e. Visualization skills, listening skills.
